November 6, 2021

The meeting was called to order by club president Roy Lawrenz at Article 15 Bar & Grill at 9:00 a.m. eighteen members were present. Thank you Article 15 for hosting the meeting!

**First Order of Business: Agenda** – A motion to approve the agenda was made by Adam Krause and second by Bob Peters. Motion approved

**Second Order of Business: Secretary Report/Minutes** – A motion to approve the minutes was made by Jerry Fry and second by Bob Paasch. Motion approved

**Third Order of Business: Treasurer Report** - Income and expenses were discussed. It was suggested to create a profit/loss statement for the groomer operations. It was noted that the AWSC allows work/operations on the groomer counted as tax exempt. The club needs to obtain a tax-exempt number. A motion to approve the report was made by Bob Peters and second by Hubert Weidermer. Motion approved

## Fourth Order of Business: Old Business

4-1 Reroute of trail on Lee Lake Road - no more discussion on this item

4-2 Trail to Coleman Swamp improvement - no updates currently

## Fifth Order of Business: New Business

5-1 Membership Report - Status of 109 new or renewed members, 2 are non-AWSC members, 52 members pending renewal. Four members donated additional funds as a donation to the club. It was suggested to send these members a letter of thanks and an AWSC sticker. The club received a nice letter from retiring club members.

5-2/5-3 Oconto County Snowmobile Alliance Meeting - there was a discussion about the items discussed at the meeting

5.4 Safeco Insurance - club members are in process of getting quotes for insuring the groomers and equipment. There was discussion on the evaluation of

the equipment. Insurance requires proof of evaluation to occur at time of loss. A motion to evaluate the groomers at \$160,000 drags at 10,000 with a \$2500 deductible a motion was made by Adam Krause and second by Brad VanHoff. Motion approved.

5-5 Amendment of Bylaws - an amendment needs to be made to the bylaws addressing the situation of a vote ending in a tie after a second vote. The determination then needs to be presented to membership.

5-6 Groomer Committee - a groomer committee was presented. Committee members include Adam Krause, Steve Garrow, Rich Marshal and Brad VanHoff. The committee will monitor maintenance and operations of the groomers

5-7 AWSC Fall Workshop/Convention - Adam Krause attended the workshop and reported on the items he learned at the meeting

5-8 Bluemound State Park usage - AWSC worked with WI assembly to gain approval for snowmobile use in Bluemound State Park; this is awaiting the Governor's signature

5-9 Landowner list - there was no discussion on this item

5-10 Trail Reports - telephone calls to landowners have all been made, brushing has been completed at multiple locations, signing has been completed at a few locations, the bridge by Klondike north of Metzners Road needs work/adjustment to correct a safety issue, a change to the trail near Klondike to the bar was discussed, a change is needed to the trail by County Road Z. The initials of the club will be noted on some orange trail blazer markers. A reminder to not do any work without prior landowner approval

## Sixth Order of Business: Additional items discussed

6-1. the contents of the storage shed needs to be insured up to \$30,000

6-2 The new trailer needs to be insured
