First Order of Business: Agenda -

Second Order of Business: Secretary Report/Minutes

Third Order of Business: Treasurer Report -

Presidents Written Report 4-1 Letter to Landowners Insurance and Memorandum - a letter, copy of insurance policy and Memorandum of Agreement for Snowmobile Trail was sent to all landowners.
