April 9, 2022

The meeting was called to order by club president Roy Lawrenz at Walker's Kracken Shack at 9:00 a.m. Twenty three people were present. Thank you Walker's Kracken Shack for hosting the meeting!

First Order of Business: Agenda – The agenda was reviewed and two items were added to the agenda - SNARS update and Fund-Raising opportunity. A motion to approve the agenda was made by Hubert Weidermer and second by Chuck Panure. Motion approved

Second Order of Business: Secretary Report/Minutes – A motion to approve the minutes was made by Tom Stadler and second by John Gagnon. Motion approved

Third Order of Business: Treasurer Report - Income and expenses were discussed. A motion to approve the report was made by Brad VanHoff and second by Tom Yingling. Motion approved.

Fourth Order of Business: Presidents Written Report - Roy completed a study of landowners that gave the club a new memorandum. 15 landowners have not returned a new memorandum but we only have documentation for 8. The club will have to work to update these records. The club will ask the landowners that did not respond again when the landowner gift certificates are sent. There was a discussion on the changes/updates for several miscellaneous and new landowners. The club received a thank you card from Linda Holtger acknowledging the flowers sent to Stan Holtgers funeral. The club acknowledged Roy Lawrenz for his years of service as the club President.

Sixth Order of Business: New Business

- 6-1 Membership Report No change to membership report
- 6-2 Groomer Report the groomers will be stored in Tanks building. The signage will be pulled off the groomers and maintenance items will be completed. Several groomer maintenance projects were discussed. There were many good reports about the condition of the trails this year. The club picked up a nice amount of money from the map box at the gas station.
- 6-3, 6-4 Trail Manager/Trail Report Bridge that washed out needs to be replaced 12x12 needs to be replaced with 20 footer. There was a suggestion to use parts from the old/unused bridge. New poles are needed for the gates by Rost Lake, we want the gates closed for Spring. The landowner is willing to move the gravel to the sunken area if we drop it.
- 6-5 Oconto County Snowmobile Alliance Meeting Report there are a few more businesses to contact about map ads
- 6-6 Meetings & Events 2022-2023 season There was a suggestion to put together a list of meeting locations and a calendar of events
- 6-7 SNARS Adam Krause was able to get a breakdown of how the club is paid and reviewed this information. Adam reviewed the number of hours and funds raised by each groomer. There was also a discussion on total grooming income

and the payment to be made for the groomer purchase. Adam stressed the importance of submitting any trail work hours on a timely basis

6-8 FundRaising Opportunity - the club has the opportunity to raffle off a 2023 Ski Doo MXZ. The snowmobile would be purchased for \$8999 from Ecklund Motorsports and they are willing to hold the sled until the raffle. 200 raffle tickets will be offered at \$100.00 per ticket. Ecklund Motorsports has asked that their name be on the raffle tickets. There was a discussion on if a raffle license was needed. Adam will check into club tax status and raffle license processes. There was a question if the raffle could be held live on Facebook. There was also a suggestion to offer 4 other dollar amount prizes. Raffle proposal - 1st prize Snowmobile, 2nd prize \$500.00, 3rd prize \$250.00, 4th prize \$100.00, 5th prize \$100.00. A motion to approve the snowmobile purchase and raffle awards pending the clubs tax status and raffle license option was made by Adam Krause and second by Peter Hyps. Motion approved.

6-9 Election of Officers for 2022-2023 season - President: Adam Krause, Vice President: Jane Garrow, Treasurer — Chuck Panure, Secretary — Cheryl Paasch, Directors — Tom Stadler, Steve Garrow, Brad VanHoff A motion to approve the election results was made by Adam Krause and second by Tom Stadler. Motion approved.

Adjournment - a motion to adjourn the meeting was made by Adam Krause and second by Brad VanHoff. Meeting adjourned
